# INTRODUCTION

The EU Ecolabel fees are applied by each EU Ecolabel [National Competent Body](#) (CB) in the European Economic Area (EEA), in accordance with the provisions of Annex III of the [EU Ecolabel Regulation](#), summarised below. The following pages provide specific information on the fees applied by each CB.

## 3 different categories of EU Ecolabel fees may apply:

1. Application fee
2. Annual fee
3. Inspection fee

### 1. Application fee

- The assessing CB shall charge a fee for processing the application.
- Maximum application fee: EUR 2 000, minimum EUR 200.
- Reductions apply for [SMEs](#), [micro-enterprise](#) and applicants from [developing countries](#), as indicated below.

200 - 2 000 EUR	Large enterprise
200 - 600 EUR	SME/developing countries
200 - 350 EUR	micro-enterprise

Further applicable reductions<sup>1</sup>:

- EMAS – registered companies: - 30%
- ISO 14001 – registered companies: - 15%

### 2. Annual fee

- The CB may charge an annual fee, either as a flat rate or based on the annual sales value of the EU Ecolabel service.
- If based on sales value, the fee shall not exceed 0.15% of that value.
- Maximum annual fee: EUR 25 000 per applicant.
- Reductions of at least 25% shall apply for [SMEs](#), [micro-enterprise](#) and applicants from [developing countries](#).

### 3. Inspection fee

The Competent Body may charge an inspection fee, as the annual fee may not cover the costs for any required on-site audit.
